The design and direction by Taller Hector Barroso allow the floorplan to flow seamlessly from detached rammed earth cubicles housing kitchen, living room and bedrooms, integrated by a palo-de-arco wood covered terrace. A deliberate focus on the use of light brings to life the internal gallery spaces and cross-ventilation allows fresh breezes keeping the residence airy and comfortable throughout the seasons.

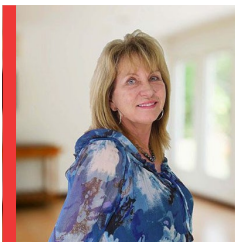
