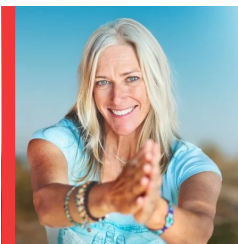
ABOUT CERRITOS CASA DE DESCANSO
